## Auditor Verification of Sampling and Analysis Quality Plan - Hoffmans Brickworks EPA Clean Up Notice ID 90010613: Requirement 3.2

I am an Environmental Auditor (Contaminated Land) appointed under Section 53S of the *Environment Protection Act 1970*. I have been engaged by Hoffmans Brickworks Pty Ltd to undertake a s53X environmental audit of part 72-106 Dawson Street, Brunswick. The portion of the site encompasses Buildings 5 and 6 and surrounds. I notified EPA of my appointment on 19 August 2019 compliant with Requirement 3.1 of the above Notice.

Requirement 3.2 of the Notice obliges the duty holder to supply EPA with an Auditor verified staged Sampling and Analysis Quality Plan (SAQP) by 27 April 2020. This letter is intended to satisfy this requirement.

The Assessor (Compass Environmental) provided the Auditor with a draft of the SAQP. Comments were provided to the Assessor who made the appropriate amendments and issued its final SAQP on 21 April 2020. This notice of verification applies to the following document:
